Tower Cranes will be manned by two (2) Class A1 operators who will receive \$3.00 per hour over their applicable rate. Tower cranes to include stationary, rail mounted, crawler mounted, hydraulic or friction. For any mode of power, crew to be assigned to crane upon start of erection and will be employed until crane is dismantled and shipped off to job. A Maintenance Engineer (Mechanic) will be employed to assist assembly, jacking of crane and disassembly. One operator is required on any Potain HDT 80 self-erecting mobile tower crane or similar.

Effective 7/1/23, all cranes with manufacturing rating of 100 ton or greater will require an oiler.

CLASSIFICATION A1: (\$3.00 over current Class A Rate)
All Cranes, or equipment that require a NYS Crane License

The following wage rates and premiums shall apply for all Districts:
Crane Operator Rates A1 Rate is \$3.00 above A Rate
Cranes 0-64 tons A1 rate
Cranes 65-110 tons A1 rate + \$1.50
Cranes 111-199 tons A1 rate + \$2.00
Cranes 200-399 tons A1 rate + \$3.00
Cranes 400-599 tons A1 rate + \$4.00
Cranes 600-799 tons A1 rate + \$5.00
Cranes 800-999 tons A1 rate + \$6.00
Cranes over 1,000 tons A1 rate + \$7.00
Tower Cranes A1 rate + \$3.00
Cranes Luffer Config. A1 rate + \$5.00
Cranes with external ballast (tray or wagon) A1 rate + \$5.00

Dues deduction is to be calculated on the total package of gross wages plus benefits.

*This amount is to be deducted from wages after the appropriate taxes have been computed.
